Renish Group launches Alaska International with higher storage capacity at Hamriyah Free Zone

enish Group, a growing company in oil space with a vision to be a global energy organization, officially launched its Hamriyah portbased storage facility, the Alaska International FZE, with higher storage capacity in March 2018.

The launch event was held in the presence of senior Hamriyah Free Zone Authority officials, Mohamed Abdulla Sultan Al Qasimi, Commercial Director, and Ali Al Jarwan, Deputy Commercial Director.

The newly launched facility will have a higher capacity at 22 tanks as part of its continuing efforts to boost its storage ability and expand its operations in the Middle East.

Renish Group acquired Alaska International in 2013 with just 60,000 cbm (cubic-meter) capacity for petroleum products. In just a few years, the company increased its storage capacity to 125,000 cbm spread across its 22 tanks, in light of expanding its operations in the region for base oil, bitumen, high centistokes (CST) fuel oil, Rubber Process Oil (RPO), and gas oil.

According to Kalrav Dixit, Executive Director, Renish Group, "Acquiring and expanding Alaska International is a timely move intended to achieve our vision to broaden our reach. The facility does not act as a storage point alone but it also allows us to expand our offerings to cover every stage of the entire supply chain system. It helps in blending, making bulk, breaking bulk of cargoes,

and many others. Additionally, as Alaska International is based in the strategically located UAE – particularly in the Hamriyah port where opportunities for bunkering, exports and blending are immense – we will now be able to efficiently meet the requirements of leading global oil players and subsequently grow our business in this area."

Alaska International's 22 tanks are uniquely configured to handle clean and dirty products with direct connection to the outer berth with a 12m draft and the inner berth with a 7m draft.

Moreover, the storage facility's dock infrastructure can handle vessels with 12.5m draft. It is served by two oil product pipelines connecting to the main docks and two oil product pipelines from the barge dock.

"Alaska International has the right capacity that can serve the various needs of our clients in the Indian subcontinent, the Red Sea, and East Africa. Our company is keen to invest more in this strategic sector as we consider the oil storage industry as the key to our further advancement and development as a business organization," Dixit added.

A decade from its inception in early 2006, the Renish Group has grown to become a \$600mn company in 2017 from a \$240mn company in 2012, with assets estimated at \$300mn.

Owning and operating a storage terminal has allowed the Renish Group to contribute to the growing trading activities in the region. In addition, investing in the sector, which is a key growth area for the organization, has also enabled the group to capture the structural benefits of the oil markets with regards to the forward curve and future derivatives trading.

amriyah Free Zone Authority (HFZA) demolished Dubai Customs (DC) by 44 runs in the Rashid Alleem Premier League Season 3 match held in Sharjah in March 2018 following a blitzkrieg of 87 by Sudeesh Ramanan.

Development works at Port Khalid sees the construction of a new state-of-the-art berth

Sharjah is home to three of the finest deep water harbors in the United Arab Emirates - Port Khalid, Port Khorfakkan and Port Hamriyah. The location of these ports have transformed Sharjah into a national and regional transport and logistics hub, as these three ports are the leading trade gateways to the UAE and handle all kinds of ships and cargoes.

While Port Khalid, a multipurpose port located in the city of Sharjah, serves as a vital entry point to the industrial heartland of the UAE, Hamriyah Port is located 18kms north of Sharjah and is adjacent to the Hamriyah Free Zone. Port Khorfakkan is a highly efficient

container terminal and is located on the East Coast of the UAE which makes it a perfect transshipment hub for the region.

In attendance at the event were Captain Mohammed Saleh, Director of Operations (Port Khalid); Captain R. Devathirajan, Harbor Master of the port; Sunil Gangadharan, Business Development Management; K.R.S. Nair, Head of Accounting Department; and other dignitaries and officials.

The overall length of the tanker which was accommodated at the berth is 274 meters with a beam of 48 meters.

Port Khalid which was established in the mid-1970s, is a pioneer among all seaports in the Gulf region and was the earliest container and Ro-Ro terminal.

With 21 berths, the Khalid Port lends itself to a variety of shipping applications, ranging from general, reefer, dry, liquid and bulk cargo to container, oil and offshore support services. The port authority also provides stevedoring services with its own labor.
